




Cost verification for major construction project

KordaMentha was engaged to provide expert witness services relating to the extent and nature of costs incurred in respect of a major marine construction project in Western Australia. The costs incurred on the project were said to have been over \$2 billion. We provided independent verification of the costs incurred using a robust sampling methodology that focussed on significant suppliers. We also conducted further verification work regarding amounts charged by related entities to assess the extent to which, if any, there were uplifts and other allocations in those costs. In addition to expert reports and joint reports, the partner involved provided oral testimony during the arbitral proceedings.

Expert assistance for international consumer products dispute

KordaMentha's forensic services were sought in a consumer products industry matter referred to the International Chamber of Commerce (ICC). The dispute arose from the termination of a Master Franchise Agreement awarded by an Australian entity to a Chinese entity covering most major territories in China. We prepared expert reports and a Joint Expert Statement responding to the claimant's expert reports on damages. The partner involved provided oral evidence at the hearing in London before a three-member arbitral panel.



Breach of an exclusive manufacturing licence agreement

KordaMentha was engaged to provide expert witness services in relation to a loss of profit claim which resulted from the alleged breach of an exclusive manufacturing license agreement. The agreement was between manufacturers based in Europe and China and related to the production of aircraft. The partner involved provided expert reports in response to the applicant's claim for damages and oral testimony (via video link) in ICC international arbitral proceedings seated in Singapore.
